## **1 General Provisions**

### **1.1 The EVOCQ® method “Energy Vibrational Oscillation & Quantum Coherence”**

This method is a process of self-empowerment, self-discovery, individuation and the opening of consciousness towards Oneness, which harnesses the virtues of the Intelligence of Light through a holistic approach based on non-separation and the integration of the universal matrix into our lives, with the aim of raising the vibrations of the planet, the collective and all living beings.

### **1.2 Our mission**

The mission of the International Academy of the **Quantum Creator®** is to preserve the purity, originality and integrity of the Method and to include in its International Register of the Academy of the Quantum Creator eligible SOLARIS Practitioners and Coaches who commit to upholding these objectives.

### **1.3 Terms and Conditions of Registration**

This Code of Professional Practice sets out the terms and conditions for registration on the Register and establishes the standards of practice for all certified practitioners and coaches in all countries.

### **1.4 The Academy reserves the right to amend the Code of Ethics to comply with regulatory requirements and changes in professional legislation.**

1.5 Practitioners and Coaches registered with the International Academy of the Quantum Creator are subject to their local laws, and any clause of the Code of Ethics that is invalid under their local law shall not apply.

## **2 Registration in the Register**

2.1 Any person who has successfully completed the SOLARIS Cristal Pro training programme, passed the final examination for the first year, been certified by the International Academy in accordance with the EVOCQ® Method, and participated in the second year of supervision may apply for registration in the Register of the International Academy of the Quantum Creator.

2.2 Admission to the Register is subject to the practitioner's confirmation, by signing at the end of the document, that he or she agrees to abide by the terms and conditions set out in the Code of Ethics.

2.3 The International Academy of the Quantum Creator reserves the right to accept or refuse an application for registration.

2.4 The Academy shall issue certified practitioners with a 'Certificate of Registration' to indicate their entry in the Register. Neither the registration nor the accompanying certificate constitutes authorisation to practise medicine or any healthcare profession that may require such authorisation; nor do they confer upon the holder the right to perform any function requiring such authorisation. Practitioners and Coaches shall be entitled to practise as SOLARIS subtle energy practitioners: **Practitioners of vibrational therapies** and/or **Coaches in Intelligence of Light** in accordance with the EVOCQ® method exclusively.

2.5 The Academy will do its utmost to support the activities and objectives of certified practitioners and coaches.

2.6 The Academy will do its utmost to provide clients with the contact details of practitioners and coaches and to publicise the services offered by certified practitioners and coaches.

2.7 All SOLARIS practitioners and coaches accept the Academy's recommendations unless they have informed the Academy otherwise.

2.8 Solaris practitioners must re-register annually as notified by the Quantum Creator Academy. Failure to renew registration will result in removal from the Register.

2.9 The International Academy of the Quantum Creator reserves the right, without notice, to suspend a registration or to cancel a registration renewal if it considers that any part of the Code has not been complied with.

### **3 Clients**

3.1 SOLARIS practitioners and coaches shall act as facilitators, and their aim shall be to support clients in applying the Simplified Method so that they may use it independently for themselves and their families.

3.2 SOLARIS practitioners will allow the process of harmonisation, spiritual elevation and awakening to proceed at the clients' own pace, so that clients gain knowledge and understanding of their own ascension processes.

3.3 SOLARIS practitioners and coaches shall receive their clients in an environment that ensures safety and confidentiality.

3.4 SOLARIS practitioners and coaches must establish and maintain clear boundaries between the practitioner/client relationship and any other form of relationship, and make these boundaries explicit to the client.

3.5 SOLARIS practitioners and coaches must demonstrate sensitivity and understanding towards the client's needs, cultural and religious background, and beliefs.

3.6 SOLARIS practitioners and coaches shall remind their clients that they remain at all times responsible for their own well-being and the expansion of their consciousness.

3.7 SOLARIS practitioners and coaches must be aware of the impact their own level of awareness will have on the client and that they must personally apply the Method to best support the client's awakening of consciousness.

3.8 SOLARIS practitioners and coaches must not exploit their clients sexually, emotionally or in any other way.

### **4 Practice**

Code of Conduct for Practitioners of the International Academy of the Quantum Creator ®

4.1 SOLARIS practitioners and coaches shall apply the highest ethical and professional standards in their practice.

4.2 SOLARIS practitioners and coaches shall at all times be mindful of and responsible for their own safety and shall take the necessary measures to ensure that their personal safety is not compromised.

4.3 If a client has requested assistance using the EVOCQ® Method, SOLARIS practitioners and coaches must not propose alternatives to the EVOCQ® Method but may, where appropriate, offer alternatives in addition to the EVOCQ® Method, provided that it is made clear that this is no longer the EVOCQ® Method.

4.4 When working with the EVOCQ® Method, SOLARIS practitioners and coaches shall confine themselves to fulfilling their role as SOLARIS practitioners and coaches and shall not attempt to treat or diagnose any physical or mental illness.

4.5 SOLARIS practitioners and coaches shall decline cases that exceed their competence as spiritual guides on the path to ascension and awakening and shall endeavour to refer such individuals to more qualified professionals: for example, other counsellors holding a medical licence.

4.6 Fees and other terms, including cancellation conditions and the level of confidentiality offered, shall be agreed upon before the first consultation takes place.

4.7 Any subsequent changes to the terms agreed in clause 4.6 shall be discussed and agreed by the client before any changes come into effect.

4.8 In relation to the concept of 'Service', fees must be fair and reasonable.

## **5 Integrity of the EVOCQ® Method**

5.1 SOLARIS practitioners and coaches shall embody the purity, originality and integrity of the EVOCQ® Method in everything they do and say.

5.2 SOLARIS practitioners and coaches must always and exclusively use the EVOCQ® method and shall not recommend, refer to or use any other selection methods or tools that they have not previously presented to the International Academy of the Quantum Creator during their training.

5.3 SOLARIS practitioners and coaches who choose to work with other approaches to spiritual development shall not allow these other approaches to affect their presentation or use of the EVOCQ® Method as a standalone modality.

## 6 Marketing

6.1 Any advertisements or promotional material that SOLARIS practitioners and coaches publish, or that are published with their consent, must avoid any false, fraudulent, misleading, deceptive or illegal statements, including, but not limited to:

6.1.1 Statements contrary to this Code;

6.1.2 Statements implying extraordinary or unique abilities, apart from their mediumship and sacred gifts used solely for the purposes of discreet and humble channelling and for energy rebalancing for the client's greater good, whilst respecting their integrity;

6.1.3 Statements comparing the benefits of the services offered with those of other practitioners and coaches;

6.1.4 Statements that are inaccurate due to their sensational, exaggerated or superficial nature;

6.1.5 Statements designed to create false or unjustified expectations of results, or which are highly likely to create such expectations;

6.1.6 Statements listing or claiming to diagnose or prescribe treatments for medical, psychiatric or veterinary conditions or symptoms.

6.2 A SOLARIS practitioner and coach registered with the International Academy of the Quantum Creator may present themselves to the public as:

6.2.1 **A SOLARIS Subtle Energy Practitioner** – specialising *in Ascension Technologies and Light Intelligence Technologies*, certified in the EVOCQ® Method by the International Academy of the Quantum Creator; or as **a Vibrational Therapist** or as **a Coach in Light Intelligence** on the path to awakening consciousness

6.3 SOLARIS practitioners and coaches registered with the International Academy of the Quantum Creator may use the International Academy of the Quantum Creator logo and the words shown above on any information material, business

cards, websites or any printed material that they produce or authorise to be produced in connection with their activity as SOLARIS practitioners of the EVOCQ® Method.

6.6 SOLARIS practitioners and coaches shall not use, nor authorise the use of, the logo of the International Academy of the Quantum Creator in any manner that might suggest that the International Academy of the Quantum Creator has approved or endorsed any training activity undertaken by the SOLARIS practitioner, unless such activities have been explicitly approved in writing.

6.7 SOLARIS practitioners and coaches shall not use, nor authorise the use of, the logo of the International Academy of the Quantum Creator on any certificate issued following training courses unless they have the express written permission of the Academy to do so.

## **7 Complaints Procedure**

7.1 It is the responsibility of the International Academy of the Quantum Creator to investigate breaches of the Code of ethics and complaints received from clients or members of the public.

7.2 It is the responsibility of the SOLARIS practitioner and coach to inform clients of the complaints procedures drawn up by the International Academy of the Quantum Creator where it is appropriate or reasonable to do so. (The remainder of this section summarises the complaints procedures. The full written procedures may be obtained on request from the Academy.)

7.3 Upon recognition of evidence that the Code of Ethics has not been adhered to, or following a written or recorded complaint regarding the conduct or actions of a SOLARIS practitioner or coach, the International Academy of the Quantum Creator shall appoint an assessor to investigate the complaint. The Assessor shall take note of the complaint by writing and sending a written notice of the complaint or breach of the Code to the SOLARIS practitioner or coach, inviting the SOLARIS practitioner or coach to respond to the Assessor within a period determined by the Assessor.

7.4 Upon receipt of the response from the SOLARIS practitioner or coach, the assessor shall gather any further information or evidence that may be relevant,

including any other statements made by the complainant and the SOLARIS practitioner or coach.

7.5 Once the investigation is complete, the assessor may take one or more of the following actions to resolve the complaint:

7.5.1 Dismiss the complaint or the reported breach;

7.5.2 Require the SOLARIS practitioner or coach to undertake further training;

7.5.3 Require the SOLARIS practitioner or coach to compensate the complainant with a sum not exceeding the cost of the sessions provided by the practitioner to the complainant

7.5.4 Recommend the suspension or revocation of the SOLARIS practitioner's registration or licence;

7.5.5 Take any other appropriate action in accordance with the Code of Ethics.

7.6 The assessor shall send the complainant and the practitioner or coach a written copy of the decision and the reasons given. The SOLARIS practitioner or coach and the complainant shall be given a period of 30 days during which they may challenge the assessor's decision. If no appeal is received within the required period, no further investigation will take place and any failure on the part of the SOLARIS practitioner or coach to comply with the assessor's decision will result in immediate removal from the Register.

7.7 Any failure by the SOLARIS practitioner or coach to comply with the decision of the International Academy of the Quantum Creator will result in their immediate removal from the Register.

7.8 The usual rights enjoyed by the SOLARIS practitioner or coach and the complainant under their local laws are not affected by the terms of this Code.

## **8 Legal Matters**

8.1 SOLARIS practitioners and coaches assume full and complete responsibility for their acts, actions, practices and omissions whilst working as SOLARIS practitioners or coaches.

8.2 By accepting the Code, the SOLARIS practitioner and coach agrees to indemnify the International Academy of the Quantum Creator and its representatives against any loss or damage they may suffer as a result of negligence or gross misconduct on the part of the SOLARIS practitioner or coach concerned.

8.3 It is the responsibility of the SOLARIS practitioner and coach to ensure that they work in compliance with the laws of the state, country or region in which they practise their profession, and to ensure that their personal and professional liability is covered by appropriate insurance.

8.4 The course materials and documents provided by the International Academy of the Quantum Creator to the SOLARIS practitioner and coach to assist them in their practice remain at all times the intellectual property of the International Academy of the Quantum Creator or of the authors cited in the teachings.

8.5 The “Quantum Creator” brand and the “EVOCQ®” method are trade marks, registered trade marks or copyrighted works of the International Academy of the Quantum Creator, and may only be used by a SOLARIS practitioner and coach registered with the Academy.

8.6 Authorisations granted by the Academy regarding the use of the logo are governed exclusively by the International Academy of the Quantum Creator and may be withdrawn by the Academy at any time.

8.7 Neither the Code of Ethics, nor the Certificate of Achievement, nor any other authorisation, nor any material provided to the SOLARIS practitioner and coach constitutes a partnership, licence, joint venture or association with the International Academy of the Quantum Creator, nor with any other organisation or body.
